(Listing Obligations and Disclosure Requirements) Regulations, 2015 – Update on
CCI Order dated 31st August, 2016

This is with reference to our earlier correspondence on the subject matter.

As informed, the Company had preferred appeals before the Competition Appellate Tribunal ("COMPAT") against order of the Competition Commission of India ("CCI") dated 31<sup>st</sup> August, 2016. Upon admission of the appeal, COMPAT had granted a stay on the CCI's orders and directed the Company to deposit an amount of Rs. 117.55 crores, which was deposited,

In the interim, the Government made changes in the constitution and operations of Tribunals, by which all matters pending before COMPAT were transferred to the National Company Law Appellate Tribunal ("NCLAT").

NCLAT, today, has disallowed all the appeals in the subject matter including the Company's appeal also. The detailed order is awaited, upon examining the same, the Company will take appropriate action, as advised by its lawyers.
